Welcome to Yaizy owned and operated by 21Skills, Inc. (“**Company**”, “**we**”, “**our**” or “**us**”)!

Yaizy operates <https://yaizy.io/> (hereinafter referred to as “**Service**”).

The Company’s Privacy Policy governs your visit to <https://yaizy.io/>, is to inform and explain how we manage, collect, use, possess, safeguard and disclose Personal Data that results from your use of our Service, which is subject to the privacy principles set out in the US Privacy Act 1974, Data Protection Act 2018 (UK) and Protection of Privacy Law 5741-1981 (Israel) and general law intended to protect your privacy, as amended from time to time, and where relevant by the European Union General Data Protection Regulations (EU) 2016/679 (the GDPR), California Privacy Protection Act (the CalOPPA) and California Consumer Privacy Act (the CCPA).

Protecting our customer’s Personal Data and compliance with Applicable Laws is of the utmost importance to Yaizy and matter we take very seriously. We are committed to properly managing, protecting, and processing your Personal Data in accordance with this Privacy Policy, which applies to all Personal Data we collect through our Website and/or other channels.

We use your data to provide and improve Service. By using Service, you agree to the collection and use of information in accordance with this policy. Unless otherwise defined in this Privacy Policy, the terms used in this Privacy Policy have the same meanings as in our Terms and Conditions.

Our Terms and Conditions (“**Terms**”) govern all use of our Service and together with the Privacy Policy constitutes your agreement with us (“**Agreement**”).

1. DEFINITIONS

SERVICE means the <https://yaizy.io/> website owned and operated by Yaizy.

PERSONAL DATA means data about a living individual who can be identified from those data (or from those and other information either in our possession or likely to come into our possession).

USAGE DATA is data collected automatically either generated by the use of Service or from Service infrastructure itself (for example, the duration of a page visit).

COOKIES are small files stored on your device (computer or mobile device).

DATA CONTROLLER means a natural or legal person who (either alone or jointly or in common with other persons) determines the purposes for which and the manner in which any personal data are, or are to be, processed. For the purpose of this Privacy Policy, we are a Data Controller of your data.

DATA PROCESSORS (OR SERVICE PROVIDERS) means any natural or legal person who processes the data on behalf of the Data Controller. We may use the services of various Service Providers in order to process your data more effectively.

DATA SUBJECT is any living individual who is the subject of Personal Data.

THE USER is the individual using our Service. The User corresponds to the Data Subject, who is the subject of Personal Data.

2. INFORMATION COLLECTION

- 2.1. We collect several different types of information for various purposes to provide and improve our Service to you.

3. TYPES OF DATA COLLECTED

3.1. Personal Data.

- 3.1.1. While using our Service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you (“**Personal Data**”).
- 3.1.2. Personally identifiable information may include, but is not limited to:
 - 3.1.2.1. Parent name and contact details (including postal address, email address and telephone numbers);
 - 3.1.2.2. Children’s names, date of birth, gender, school, medical conditions and any other relevant information you share with us;
 - 3.1.2.3. The names and telephone numbers of adults parents authorize to collect your children or to be contacted in the event of an emergency;
 - 3.1.2.4. Information about activities on our website and about the device used to access it, for instance your IP address and geographical location;
 - 3.1.2.5. Bank or credit card details. If parents make a purchase, your card information is not held by us, it is collected by our third party payment processors, who specialize in the secure online capture and processing of credit/debit card transactions;
 - 3.1.2.6. Any other personal information shared with us, emergency contact.
- 3.1.3. We may use your Personal Data to contact you with newsletters, marketing or promotional materials and other information that may be of interest to you. You may opt out of receiving any, or all, of these communications from us by emailing at hello@yaizy.io.

3.2. Usage Data.

- 3.2.1. We may also collect information that your browser sends whenever you visit our Service or when you access Service by or through a mobile device (“**Usage Data**”).
- 3.2.2. This Usage Data may include information such as your computer's Internet Protocol address (e.g. IP address), browser type, browser version, the pages of our Service that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.
- 3.2.3. When you access Service with a mobile device, this Usage Data may include information such as the type of mobile device you use, your mobile device unique ID, the IP address of your mobile device, your mobile operating system, the type of mobile Internet browser you use, unique device identifiers and other diagnostic data.

3.3. Location Data.

- 3.3.1. We may use and store information about your location if you give us permission to do so (“**Location Data**”). We use this data to provide features of our Service, to improve and customize our Service.
- 3.3.2. You can enable or disable location services when you use our Service at any time by way of your device settings.

3.4. Tracking Cookies Data.

- 3.4.1. We use cookies and similar tracking technologies to track the activity on our Service and we hold certain information.
- 3.4.2. Cookies are files with a small amount of data which may include an anonymous unique identifier.
- 3.4.3. Cookies are sent to your browser from a website and stored on your device.
- 3.4.4. Other tracking technologies are also used such as beacons, tags and scripts to collect and track information and to improve and analyze our Service.
- 3.4.5. You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Service.

3.4.6.Examples of Cookies we use:

- 3.4.6.1. **Session Cookies:** We use Session Cookies to operate our Service.
 - 3.4.6.2. **Preference Cookies:** We use Preference Cookies to remember your preferences and various settings.
 - 3.4.6.3. **Security Cookies:** We use Security Cookies for security purposes.
 - 3.4.6.4. **Advertising Cookies:** Advertising Cookies are used to serve you with advertisements that may be relevant to you and your interests.
 - 3.4.6.5. **Necessary / Essential Cookies:** These Cookies are essential to provide You with services available through the Website and to enable You to use some of its features. They help to authenticate users and prevent fraudulent use of user accounts. Without these Cookies, the services that You have asked for cannot be provided, and We only use these Cookies to provide You with those services. These Cookies include, for example, cookies that enable you to log into secure areas of our website, use a shopping cart or make use of e-billing services.
 - 3.4.6.6. **Cookies Policy / Notice Acceptance Cookies:** These Cookies identify if users have accepted the use of cookies on the Website.
 - 3.4.6.7. **Functionality Cookies:** These Cookies allow us to remember choices You make when You use the Website, such as remembering your login details or language preference. The purpose of these Cookies is to provide You with a more personal experience and to avoid You having to re-enter your preferences every time You use the Website.
 - 3.4.6.8. **Analytical/performance cookies:** They allow us to recognize and count the number of visitors and to see how visitors move around our website when they are using it. This helps us to improve the way our website works, for example, by ensuring that users are finding what they are looking for easily.
- 3.4.7.You can find a list of Cookies that we use in the Cookies Schedule.
- 3.4.8.You can choose to enable or disable Cookies in your internet browser. By default, most internet browsers accept Cookies but this can be changed. For further details, please consult the help menu in your internet browser.
- 3.4.9.You can choose to delete Cookies at any time; however you may lose any information that enables you to access the Website more quickly and efficiently including, but not limited to, personalization settings.
- 3.4.10. It is recommended that you ensure that your internet browser is up-to-date and that you consult the help and guidance provided by the developer of your internet browser if you are unsure about adjusting your privacy settings.
- 3.4.11. For more information generally on cookies, including how to disable them, please refer to aboutcookies.org. You will also find details on how to delete cookies from your computer.
- 3.4.12. **How we collect Data.** We collect Data in the following ways:
- 3.4.12.1. data is given to us by you;
 - 3.4.12.2. data is received from other sources; and
 - 3.4.12.3. data is collected automatically.
- 3.4.13. **Data that is given to us by you.** Yaizy will collect your Data in a number of ways, for example:
- 3.4.13.1. when you contact us through the Website, by telephone, post, e-mail or through any other means;
 - 3.4.13.2. when you make payments to us, through this Website or otherwise;
 - 3.4.13.3. when you elect to receive marketing communications from us;
 - 3.4.13.4. when you use our Services.
- 3.4.14. **Data that is received from third parties sources.** We will receive Data about you from the following available third party sources:

- 3.4.14.1. subcontractors acting on our behalf who provide us with technical, payment or delivery services;
- 3.4.14.2. our business partners, advertising networks analytics providers and search information providers;
- 3.4.14.3. social media.
- 3.4.15. **Data that is collected automatically.** To the extent that you access the Website, we will collect your Data automatically, for example:
 - 3.4.15.1. we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and
 - 3.4.15.2. includes your IP address, the date, times and frequency with which you access the
- 3.4.16. Website and the way you use and interact with its content. We will collect your Data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on the Website, see the section below, headed "Cookies".

4. USE OF DATA

- 4.1. Yaizy uses the collected data for various purposes:
 - 4.1.1. to provide and maintain our Service;
 - 4.1.2. to notify you about changes to our Service;
 - 4.1.3. to allow you to participate in interactive features of our Service when you choose to do so;
 - 4.1.4. to provide customer support;
 - 4.1.5. to gather analysis or valuable information so that we can improve our Service;
 - 4.1.6. to monitor the usage of our Service;
 - 4.1.7. to detect, prevent and address technical issues;
 - 4.1.8. to fulfill any other purpose for which you provide it;
 - 4.1.9. to carry out our obligations and enforce our rights arising from any contracts entered into between you and us, including for billing and collection;
 - 4.1.10. to provide you with notices about your account and/or subscription, including expiration and renewal notices, email-instructions, etc.;
 - 4.1.11. to provide you with news, special offers and general information about other goods, services and events which we offer that are similar to those that you have already purchased or enquired about unless you have opted not to receive such information;
 - 4.1.12. in any other way we may describe when you provide the information;
 - 4.1.13. for any other purpose with your consent.

5. RETENTION OF DATA

- 5.1. We will retain your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy.
- 5.2. We will retain and use your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.
- 5.3. We will also retain Usage Data for internal analysis purposes.
- 5.4. Usage Data is generally retained for a shorter period, except when this data is used to strengthen the security or to improve the functionality of our Service, or we are legally obligated to retain this data for longer time periods.

6. TRANSFER OF DATA

- 6.1. Your information, including Personal Data, may be transferred to – and maintained on – computers located outside of your state, province, country or other governmental jurisdiction where the data protection laws may differ from those of your jurisdiction.

- 6.2. If you are located outside United States and choose to provide information to us, please note that we transfer the data, including Personal Data, to United States and process it there.
- 6.3. Your consent to this Privacy Policy followed by your submission of such information represents your agreement to that transfer.
- 6.4. Yaizy will take all the steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will take place to an organization or a country unless there are adequate controls in place including the security of your data and other personal information.

7. DISCLOSURE OF DATA

7.1. We may disclose personal information that we collect, or you provide:

7.1.1. Business Transactions.

7.1.1.1. If the Company is involved in a merger, acquisition or asset sale, Your Personal Data may be transferred.

7.1.1.2. We will provide notice before Your Personal Data is transferred and becomes subject to a different Privacy Policy.

7.1.2. Disclosure for Law Enforcement.

7.1.2.1. Under certain circumstances, we may be required to disclose your Personal Data if required to do so by law or in response to valid requests by public authorities.

7.1.3. Other cases. We may disclose your information also:

7.1.3.1. to our subsidiaries and affiliates;

7.1.3.2. to contractors, service providers, and other third parties we use to support our business;

7.1.3.3. to fulfill the purpose for which you provide it;

7.1.3.4. for any other purpose disclosed by us when you provide the information;

7.1.3.5. with your consent in any other cases;

7.1.3.6. if we believe disclosure is necessary or appropriate to protect the rights, property, or safety of the Company, our customers, or others.

7.1.4. **Who we share Data with.** We may share your Data with the following groups of people for the following reasons:

7.1.4.1. our employees, agents and/or professional advisors - to in order to achieve the other purposes set out in this policy;

7.1.4.2. third party payment providers who process payments made over the Website - to enable third party payment providers to process user payments and refunds.

8. SECURITY OF DATA

8.1. The security of your data is important to us but remember that no method of transmission over the Internet or method of electronic storage is 100% secure.

8.2. We strive to use commercially acceptable means to protect your Personal Data, we cannot guarantee its absolute security.

9. YOUR RIGHTS

9.1. You have the following rights in relation to your Data:

9.1.1. Right to access - the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.

9.1.2. Right to correct - the right to have your Data rectified if it is inaccurate or incomplete.

9.1.3. Right to erase - the right to request that we delete or remove your Data from our systems.

- 9.1.4. Right to restrict our use of your Data - the right to "block" us from using your Data or limit the way in which we can use it.
- 9.1.5. Right to data portability - the right to request that we move, copy or transfer your Data.
- 9.1.6. Right to object - the right to object to our use of your Data including where we use it for our legitimate interests.
- 9.2. To make enquiries, exercise any of your rights set out above, or withdraw your consent to the processing of your Data (where consent is our legal basis for processing your Data), please contact us via this e-mail address: hello@yaizy.io.
- 9.3. If you are not satisfied with the way a complaint you make in relation to your Data is handled by us, you may be able to refer your complaint to the relevant data protection authority.
- 9.4. It is important that the Data we hold about you is accurate and current. Please keep us informed if your Data changes during the period for which we hold it.

10. Your Data Protection Rights Under General Data Protection Regulation (GDPR)

- 10.2. We aim to take reasonable steps to allow you to correct, amend, delete, or limit the use of your Personal Data.
- 10.3. If you wish to be informed what Personal Data we hold about you and if you want it to be removed from our systems, please email us at hello@yaizy.io.
- 10.4. In certain circumstances, you have the following data protection rights:
 - 10.4.1. the right to access, update or to delete the information we have on you;
 - 10.4.2. the right of rectification. You have the right to have your information rectified if that information is inaccurate or incomplete;
 - 10.4.3. the right to object. You have the right to object to our processing of your Personal Data;
 - 10.4.4. the right of restriction. You have the right to request that we restrict the processing of your personal information;
 - 10.4.5. the right to data portability. You have the right to be provided with a copy of your Personal Data in a structured, machine-readable and commonly used format;
 - 10.4.6. the right to withdraw consent. You also have the right to withdraw your consent at any time where we rely on your consent to process your personal information;
- 10.5. Please note that we may ask you to verify your identity before responding to such requests. Please note, we may not be able to provide Service without some necessary data.
- 10.6. You have the right to complain to a Data Protection Authority about our collection and use of your Personal Data. For more information, please contact your local data protection authority in the European Economic Area (EEA).

11. Your Data Protection Rights under the California Privacy Protection Act (CalOPPA)

- 11.1. CalOPPA is the first state law in the nation to require commercial websites and online services to post a privacy policy.  - 12.1.1.7. A list of categories of personal information that we have disclosed for a business purpose, along with the category of any other company we shared it with.
- 12.2. Please note, you are entitled to ask us to provide you with this information up to two times in a rolling twelve-month period. When you make this request, the information provided may be limited to the personal information we collected about you in the previous 12 months.
 - 12.2.1. **To delete your personal information.** If you make this request, we will delete the personal information we hold about you as of the date of your request from our records and direct any service providers to do the same. In some cases, deletion may be accomplished through de-identification of the information. If you choose to delete your personal information, you may not be able to use certain functions that require your personal information to operate.
 - 12.2.2. **To stop selling your personal information.** We don't sell or rent your personal information to any third parties for any purpose. You are the only owner of your Personal Data and can request disclosure or deletion at any time.
- 12.3. Please note, if you ask us to delete or stop selling your data, it may impact your experience with us, and you may not be able to participate in certain programs or membership services which require the usage of your personal information to function. But in no circumstances, we will discriminate against you for exercising your rights.
